MEMBERSHIP TYPES

- International:** \$56.00 – Subscribing membership not served by U.S. Postal Service; includes access to SCA electronic Kingdom newsletters. **Printed newsletters may be purchased for an additional fee.** They are eligible to hold office and other privileges designated.
- Associate:** \$30.00 – Membership only. Publications and electronic newsletters are not available for this membership type.
- Family:** One additional adult and any minor children 21 and under residing at the same address as an International Member. Family members are extended the privileges of Associate Membership. A maximum of \$86 will be collected from families with one International and three or more family members (\$56 + \$30).

NOTE: A separate application form must be completed and signed for each family member.

Memberships are effective immediately upon receipt of properly completed applications and payment. Subscriptions may take 4 to 7 weeks for processing. For confirmation, send a self-addressed, blank postcard. One postcard per person. No index cards, please. We're sorry, but we cannot send fax confirmations. Please send all payments in U.S. funds only.

PROCESSING TIME: 4-7 WEEKS

The cutoff for each month is NOON of the last working day of the month. Forms that come in after the cutoff date are processed for the following month. Printed newsletter cycle is two months ahead: January payments are for March mailing labels, etc.
