As such, I will discuss with Kingdom Seneschals the benefits of requesting that each Kingdom provide my office with an annual update of all zip codes per local group. Furthermore, based upon the growth of the SCA, it would appear that we need to secure specific border between Kingdoms. This will require all Kingdoms to effectively coordinate their border zip codes with their adjacent kingdoms at Meridies and Atlantia did recently.

## Shire of Fiach Ogain (Pasco County, FL)

After discussion with nearby groups and polling of the members residing within the county, it was decided to split the zip codes among the neighboring groups. The member residents have already established patterns of participation with the neighboring groups that roughly correspond with a landmark division marked major highways which bisect the county north-south and east-west. The participation is established enough that members in these zip codes are already holding offices in those groups, assuring that they will integrate well, and that changing their group assignment is mostly a formality. Zip code lines roughly follow this landmark division as well, providing a good, common sense explanation of the division. Additionally, this area and its groups have a long-running tradition of welcoming participants to be active in their groups regardless of where in the Tampa Bay Area they reside, providing further assurance of success with this split.

## Commendations

In this quarter, the DSM Rapier wishes to commend the principals of the grappling experiment in the Middle Kingdom, who have with considerable enthusiasm taught many fencers from far and wide about their program so that these fencers may seed new experiments in other kingdoms. Compliments to Master Cecil, Warder Phillip, Master Rafael, Master Tedesco, and the others who are leading this program in the Midrealm.

- Known World MoAS Summit (March 2019): The planned summit has been approved by the Gulf Wars. I plan on holding this in the artisan's row during the Tuesday evening of the war. With luck, we'll have a potluck for refreshments and many discussions about the arts and sciences of the Known World.
- Known World Costume & Fiber Arts (June 2019): Known World Costume and Fiber Arts Symposium 2019 will be hosted by the Shire of Talmere in Kingdom of Meridies from June 21st through June 23rd 2019. It will be at the University of West Georgia in Carrollton, GA, and partially sponsored by the University's Anthropology Department.
- Known World Cooks & Bards (September 2019): Known World Cooks and Bards Symposium 2019 will be hosted by the Barony of Shattered Crystal in the Midrealm from August 29th through September 2nd 2019. It will be at Camp Dubois (a reproduction of the winter fort for the Lewis & Clark expedition) in Wood River, IL. The site does boast a blacksmith shop and two clay baking ovens.

• Known World Agricultural & Forestry (September 2019): Known World Agricultural and Forestry Symposium 2019 will be hosted by the Barony of the Sacred Stone in Kingdom of Atlantia from August 30th through September 1st 2019.
