AUTHOR'S RELEASE FORM

Articles can be submitted to the Editor as an e-mail attachment, on a disk/CD, or on paper. Files should be saved as ClarisWorks 6 (Mac), MS Word (PC), Rich Text Format or ASCII text. Do not use automatic bullets, tables, or other formatting features.

Artwork and photos *associated with an article* should be submitted to the Editor with the article. Artwork should be in dense, black ink on opaque white paper or digital (300 dpi TIFF or EPS). If digital, submit as separate files, not as graphics placed within a file. Photos should be on photo paper or digital (300 dpi TIFF).

Submitting

E-MAIL (preferred)

1) E-mail to Editor (tieditor@sca.org):

- a) Article, artwork and photos as attachments.

2) Mail to Editor:

- a) Completed Author's Release Form (and any other releases for artists, photographers, models and additional authors).
- b) Hard copy of article.

DISK/CD

1) Mail to Editor:

- a) Either 3.5" disk (PC) or CD (Mac or PC), labeled with your modern name and phone number, as well as the file name and format of each file.
- b) Completed Author's Release Form (and any other releases for artists, photographers, models and additional authors).
- c) Hard copy of article.

PAPER

1) Mail to Editor:

- a) Typed or printed article with an easy-to-read typeface such as Times or Courier, and printed on one side of the sheet only.
- b) Completed Author's Release Form (and any other releases for artists, photographers, models and additional authors).
