My usual disclaimer: This report contains some highlights and information from the January 30, 2022, meeting. It has the publishable summaries and commendations from all Society and Corporate officers that submitted reports.

Sanctions and other items done under Executive Session (the closed part of a Board meeting in which personnel and sensitive issues are discussed and handled) are at the end of this report.

### **Status Changes Requiring Board Action:**

The incipient Shire of Windgate (Shelby, Montana) in the Kingdom of Artemisia advancement to full status was the only status change this quarter.

### **2022 Budget**

### **Variations Granted by Society Seneschal**

1. Midrealm: Variance granted for the Crown of the Middle to hold a virtual court on January 15, 2022, in place of the canceled Festival of Maidens that had been planned as an in-person event. Variance granted December 28, 2021.
2. Ansteorra: Variance granted for the Crown of Ansteorra to hold a virtual court on January 1, 2022, in place of the canceled Steppes Twelfth Night event that had been planned as an in-person event. Variance granted December 30, 2021.
3. Ansteorra: Variance granted for Ansteorra to delay its Crown Tournament, originally scheduled for January 2022 in accordance with kingdom law, until a date when it is safer to hold the event in light of the current high number of COVID cases. Should the tournament be rescheduled without enough lead time for normal newsletter publication, this variance includes permission for the tournament flyer to be published on the kingdom website and official social media channels in lieu of the newsletter. Variance granted January 4, 2022. (Note: Ansteorra had already met the requirement for the "COVID Royalty" to be replaced by January 31, 2022.)
4. Drachenwald: Variance granted for Drachenwald to hold a virtual Coronation ceremony on the previously planned date of January 8, 2022, due to COVID restrictions in a number of countries in the kingdom. Variance granted December 31, 2021.
5. Drachenwald: Variance granted for Drachenwald's Spring Crown Tourney, originally scheduled for March 5, 2022, to be postponed until the Double Wars event, to be held May 20-29, 2022. The postponement is due to COVID restrictions in Sweden. The exact date of the tournament, once established in the Double Wars schedule, will be publicized. Variance granted January 18, 2022.
6. Meridies: Variance granted for Midwinter Arts and Sciences event to be a virtual event, including a virtual court, on February 5, 2022. Variance granted January 4, 2022.
7. Meridies: Variance granted for the Crown of Meridies to hold a virtual court on January 15, 2022, in lieu of an in-person event scheduled and publicized for that date which was canceled due to COVID concerns. Variance granted January 10, 2022.

8. Meridies: Variance granted for the Barony of Thor's Mountain to convert their Black Gryphon event to be held February 12, 2022, to a virtual event, to include a royal court. Variance granted January 19, 2022.
9. Northshield: Variance granted for the Crown of Northshield to hold a virtual court on January 15, 2022, in lieu of a previously-published in-person Twelfth Night event. Variance granted January 4, 2022.
10. Ealdormere: Variance granted for their January 22 Coronation, which had been publicized to be an in-person event, to convert to a virtual event, including virtual courts. Variance granted January 5, 2022.
11. Atlantia: Variance granted for the Kingdom Twelfth Night, originally scheduled to be a live event on January 15, to convert to a virtual event, including virtual courts. Variance granted January 5, 2022.
12. Artemisia: Variance granted for the Shire of Stan Wyrn to change the site of a published event scheduled for February 12, 2022, due to a scheduling conflict with the original site. Variance granted January 6, 2022.
13. Outlands: Variance granted for the Barony of Caerthe's Twelfth Night event, scheduled for January 8, 2022, to convert to a virtual event and court. Variance granted January 6, 2022.
14. Aethelmearc: Variance granted to Aethelmearc kingdom law regarding officer terms, specifically to allow the Kingdom Chatelaine to remain in office for an additional year due to the inability of the designated successor to serve. Variance granted January 11, 2022.
15. Caid: Variance granted for King Pansa of Caid to miss his successors' coronation due to health reasons. His reign is considered complete, and his County rank is hereby acknowledged, effective January 8, 2022. Variance granted January 11, 2022.
16. Atenveldt: Variance granted to cancel the Atenveldt Crown Tourney scheduled for January 22, 2022, until a future date to be determined. That future date cannot be later than the date of the regularly scheduled next Coronation, which in that case would be combined with the Crown Tournament unless an additional variance is granted. Variance granted January 19, 2022.

#### **The Society for Creative Anachronism LTD New Affiliate Agreement.**

A new Affiliate Agreement was approved by the Board in response that all Affiliates use January 31 as the date their payments will be due to SCA, Inc.

#### **Corpora X. Grievances and Sanctions, Section B. Grievances**

The Board has approved the removal Corpora X. *Grievances and Sanctions*, Section B. *Grievances* from Corpora. X.B. *Grievances*, as was written, was a recommended but not mandated section of Corpora. This has created some confusion considering as current SCA procedures and rules as

listed in Corpora are supposed to be mandatory. The corrected text will be forthcoming.

### **Society Seneschal - Policy Interpretation Corpora I.A. "Precedence of Law"**

Royalty may not act or instruct their populace to act in ways that are contrary to their own kingdom laws. They have the right to change a law with which they disagree, following the procedures spelled out in Corpora and their own kingdom law, but not to temporarily override it. If for some reason it is believed that a temporary override of a kingdom law is necessary, a specific variance must be requested from the Society Seneschal.

### **Laurel Principal Queen of Arms – Approved SENA Changes**

1. SENA (Standards for Evaluation of Names and Armory: Approval of a change to PN5B5 and NPN5B5 to add a reference to Appendix N, Banned and Potentially Problematic Place Names.
2. Administrative Handbook: approval of a change in the way joint registration of names and badges is treated. Prior to the updates, the secondary owner essentially had no control over the jointly registered item; the joint ownership was effectively a simple label. Under the revised rule, the secondary owner's rights are expanded to nearly match those of the primary owner: the primary owner may still remove the secondary owner or transfer the item without the secondary owner's consent, but otherwise both owners have the same control. These changes affect sections I.B Registration Limits, II.A.4 Names Which May be Registered to Individuals - Household or Association Names, and II.D.2 Armory Which May be Registered to Individuals.

### **Peerage Committee – Statement by the Board**

The Board thanks the Peerage Committee for their good work. To inform future discussions, it requests the Committee investigate what potential changes to the governing documents would look like if adopted. It will restrict itself to part one of its proposal. Thank you for your help considering this important aspect of the SCA experience. *The Board notes that there has been no decision at this time and looks forward to future discussions and returns these matters to the Committee for additional work.*

How do we capture musical sound in written form? Musicians have been struggling with this problem for thousands of years. Musical notation has evolved and changed radically over that time, meaning that most modern musicians cannot read archaic notations. Unfortunately, that leaves a large body of music locked away to musicians wishing to perform it. The purpose of this *Compleat Anachronist* is to help unlock some of that music. The author's goal is to provide those familiar with modern musical notation a sufficient framework for further study and exploration, along with some tangible examples of how to transcribe various types of notation that appear in the Middle Ages and Renaissance.
