2022 Annual Report

The 2022 Annual Report created by the Communications Team was approved and should be posted on the website, in the near future.

Diversity, Equity and Inclusion (DEI) Initiatives

The following DEI Initiatives by the Diversity, Equity, Inclusion and Belonging (DEIB) (formerly the DEI) Officer were accepted as presented:

- Identify or create a specific set of training materials and record keeping processes appropriate for Board members, Corporate and Society officers, corporate office staff, Kingdom Great Officers, and other relevant positions.
- Collaborate with the Society Seneschal and existing kingdom DEI officers to understand the current roles and responsibilities and explore the potential creation of Kingdom DEI officers.
- Collaborate with the Society Chatelaine to identify appropriate DEI training materials to further all Chatelaine's recruitment and retention efforts.
- Collaborate with appropriate officers to develop through directed research and community outreach to create a site accessibility repository.
- Form a workgroup to investigate the potential creation of a Society DEI officer and the roles and responsibilities associated with the position.

The following actions for the DEIB office were approved:

Motion by Pug Bainter, in alignment with the January 2023 strategic DEI initiative, to direct the Corporate DEI Officer to finalize and deliver appropriate procurement documents to acquire a strategy consultant to perform a DEI assessment of the organization. Second by Jennifer Krochmal. Opposed: None. Motion carried.

Motion by Mark Faulcon to approve changing the name of the Diversity, Equity and Inclusion Office to the Diversity, Equity, Inclusion and Belonging Office, as requested by the Corporate DEI Officer. Second by K.T. Sheppard. Opposed: None. Motion carried.

SCA Archives – Physical Transfer of Documents

Commendations were issued by the Board and President to CT Alderson, Travis Schenck and Laura Pate for their work on transferring the physical archives from their previous storage facility in California, to the new facility in Spanish Fork, Utah.

Society Exchequer - Financial Policy Approval:

Motion by Jennifer Krochmal to approve the Kingdom of Atlantia Financial Policy as presented by the Society Exchequer. Second by Mark Faulcon. Opposed: None. Motion carried.

Motion by Jennifer Krochmal to approve the Kingdom of Northshield PayPal Policy to the Society Exchequer as presented by the Society Exchequer. Second by Gabrielle Fisher. Opposed: None. Motion carried.

Laurel Principal Queen of Arms – Approved SENA Changes

1. Addition of two examples to SENA PNP3C6, “Examples of Personal Name Conflict Checks,” to illustrate that the addition of an article or preposition is insufficient to clear conflict.
2. Revision of SENA PN4D1, “Non-SCA People Protected from Presumption,” to clarify that consideration of encyclopedia entries for determining if a non-SCA person is important enough to protect under this section is not limited to English-language encyclopedias, nor to print versions of encyclopedias.
3. Revision of SENA NPN1C2f, “Branch Name Allowance” to allow order names with a double locative to use at Branch name based on period examples of order names.
4. Revision of SENA NPN4D1, “Non-SCA Entities Protected from Presumption,” to make it explicit that names of indigenous tribes and other groups of people are among the names we protect from presumption. Also, a revision to clarify that consideration of encyclopedia entries for determining if a non-SCA entity is important enough to protect under this section is not limited to English-language encyclopedias, nor to print versions of encyclopedias.
5. Revision to how we treat attested depictions of fantastical plants and animals. Previously they were under SENA A2B4a, “Elements which are a Step from Core Practice – Plants and Animals”, but now are handled under SENA A2B2b, “Constructed Elements – Plants and Animals” as there is a pattern of using fantastical plants and animals in period heraldry. Also, a revision to SENA A2B4a to clarify that when we say “known to period people” we mean people of any culture, not just Europeans.
6. Revision of the example in SENA A6F2b, “Designs which Create the Appearance of Marshalling – Sections which are Subdivided,” to make it clear that checky quarters do not create the appearance of marshalling.

7. Added a header to Appendix C “Regional Naming Groups and Their Mixes” to clarify what regional naming groups are, to specify the maximum number of years between elements for mixing, and to add links back to the relevant sections in SENA PN2.
8. Updated Appendix E4 “Household Names” to add the designator *Sodalitas*, a Latin form of “fellowship”.
9. Updated Appendix H “Low-Contrast Complex Lines of Division” to allow fields that are divided *per pale offest*, *per bend (sinister) bevilled*, or *per fess with a (left or right) step* to be registered in any pair of low contrast tinctures so long as there is no charge overlaying the division, which would reduce identifiability.
10. Updated Appendix I “Charge Group Theory” to clarify that labels may be in chief and overlie peripheral ordinaries without overlying the primary charge. This matches period practice and aligns Appendix I with Appendix J.
11. Updated Appendix J “Documented and Forbidden Arrangements of Charge Groups on Armory” to clarify one of the disallowed patterns under the heading "Designs with One or Two Charge Groups On the Field that We Don't Allow (barring evidence that they were used in period)" applies only to charges in a single group.
12. Changes to the Glossary of Terms - Updated Table 4 “Conventional ‘Proper’ Colorings” to include definitions for holly branch and panda.
13. Changes to the Glossary of Terms - Updated Table 5 “Conventional S.C.A. Default Postures” for ships.
14. Changes to the Administrative Handbook appendices Updated Appendix H “Sources That Do Not Require Photocopies to Laurel to include *Diplomatarium Islandicum* and articles by Gunnvorr Silfarhárr (the Viking Answer Lady).

President – John Fulton (John the Bearkiller)

Commendations:

I would like to thank Louise Du Cray and Nataalya Urosevic in their handling the tasks of working with Neon in the efforts to complete the changeover for SCA.org website to the new platform. There have been harsh weather issues in San Jose also over the last several months that further complicated all that hard work. In addition to keeping the SCA office running also.

Sam Davis, the SCA's Manager of Information Technology, has been a steady and reliable source of all tech wise matters.

Carolyn Richardson's efforts, as SCA Treasurer, have been exemplary over the last number of months. She has frankly been wonderful.

Publishable Summary:

SCA, Inc. received a \$2322.15 donation from the AmazonSmile program for activity between October 1 and December 31, 2022. Amazon is discontinuing this program for not-for-profits and the last donation from Amazon will be made in May 2023. It is unfortunate that Amazon has decided to end this offering, but the company has been generous over the years and none of the money donated to the SCA from AmazonSmile came from any customers. This was donated by the company itself.

Charles Burk, Baron Charles de Bourbon, OL is settling into the office of Diversity, Equity, and Inclusion. The Board released a proposed plan and schedule for the office in January 2023 and Charles is focusing not only on seeing the plan is properly administered but that the office continues to flourish and grow to meet the needs of the now and future of the Society and all who participate.

Katie Gilroy (Lady Margery Heron) is the new Marketing Deputy under Brigid Costello's Communication office. Katie has designed two shirts which are the first official SCA "Merch". Charles Burk in his capacity as the SCA DEI officer is responsible for deciding the most effective use of the funds generated by the sale of the shirt.

Ray DuBose's, Sir Rey RiBeaumont, warrant as Society Marshal is nearing the end of term and we will begin advertising the position in April to select a new Society Marshal.

Insurance costs have risen over the Covid years. There will soon be an announcement regarding raising the price for all group insurance certificates. It has been several years since insurance certificates have been increased. The increase will be as minimal as possible and the announcement will carry much more detailed information on which insurance costs have increased. Please keep in mind that these certificate costs are paid for by groups.

Plans are finalized for the movement of the SCA Archives from their current home in California

to their new home in Utah. Shipping and housing of the approximately 150 boxes of past and current treasure should be completed by the end of April. Leslie not only takes it on herself to answer emails to the Board's Comments address, but she has helped me tremendously in composing and editing emails that were mine to answer. She is fabulous.

I also want to mention my two stellar deputies, Stacy Hall (Mistress Gwenndolynn ni hAilleachain) and Becky Littlefield (Mistress Alinore Wyndover). Between the two of them they are managing to educate me on easier, clearer ways to use technology to organize my Board reports, as well as being available as listening ears for some of the inevitable frustrations that come with this job.

Finally, I want to mention two citizens of Lochac who stepped up to help the kingdom when needed: Kellianne Anderson (Countess Beatrice), and Andrew Ross-Gowan (Baron Gilchrist). I know the kingdom appreciates their willingness to assist, as do I.

From the kingdom seneschals I have the following commendations:

Ansteorra: I would like to give thanks to Mistress Simha for serving as calendar deputy during this time of many changes. She has been astalwart officer, always staying on top of the changes and doing it with kindness.

Atlantia: It has been a pleasure working with King Abran and Queen Anya. This is their first time reigning, so they have lots of questions. But their questions have forced me to keep on my toes and have made me a better KS.

Caid: A big round of applause to Tiberius for the work he did in this office and his support of my tenure. His is a bedrock in the kingdom.

East: I'd like to thank the local seneschals of the East for their steadfast support of their local members. They have been integral in managing a *lot* of opinions through the last quarter, and have done a stellar job communicating back to me. I owe them a debt of gratitude as I worked through a series of disabling conditions which made the use of a computer hard over the last 2 months.

Northshield: I do want to commend Hraði Bjarnylr mka Reid Wooldridge, Seneschal of the Barony of Windhaven, he is stepping down after this reporting cycle and has done an excellent job in his tenure. He is a sure constant in dependability which in our position is always a great asset. He is a great asset to our Kingdom.

Publishable Summary:

Several large events occurred during the first quarter of the year in various kingdoms, including the return of the Birka Market in the East, several Twelfth Night coronations, and Gulf Wars, with the Kings Arrow Ranch site under new and enthusiastic ownership. Also Atenveldt held an event, War of the Phoenix, in early February which is reported to have been a success.

Attendance at such events seems to be exceeding expectations and certainly exceeding events last winter, assuming those events in early 2022 were able to be held at all. This winter happily did not see a large COVID surge such as last winter brought. All remaining variances for COVID restrictions were allowed to expire March 1; of course if that situation were to change they would be re-examined.

As most of the SCA seems to have returned to near-normal after the long period of lessened activity, it's worth mentioning that variances to kingdom laws or Society rules and policies, which were unfortunately quite common as we coped with the extraordinary circumstances of the last few years, are once again something that should be relatively rare. Variances are for unavoidable, extraordinary circumstances—the classic example is a natural disaster rendering a Crown or Coronation site unusable and requiring a last-minute change of date or venue—and should not be requested when other solutions to a problem can be found. If a kingdom law is not serving the kingdom well, the Crown and kingdom officers should consider changing the law.

The new Society Chatelaine and new Society Youth Activities Officer have both geared up for activity this quarter. Kingdom chatelaines and kingdom youth officers are highly encouraged to contact these Society officers whose job is largely to network and support the kingdoms in their recruiting and family-oriented endeavors.

As the warm-weather event season returns, I do feel the need to remind people that the SCA has expectations for behavior toward other participants and at events. Most of these can be found on the SCA.org website, in a section titled “Conduct and Behavior in the SCA.” While there are a large number of documents linked there, they boil down to treating your fellow SCA participants with kindness and courtesy. We're all here to have fun and enjoy each other's company while sharing our interest in history. Be safe out there, maybe try something new, and take advantage of all the SCA has to offer.

Youth Officers all over the Society are meeting and discussing the needs of SCA families. We are compiling resources and information not only for Youth Officers but for parents and teens. This information will soon be available on the SCA website.

Vice President for Corporate Operations – Louise Du Cray

Commendations:

I would like to thank the other half of the SCA Corporate Office, Nataalya. As our administrative assistant, QuickBooks whiz, and stock clerk, Taalya wears many different hats, and does a lot more behind the scenes than may be readily apparent. She has spent countless hours cross-checking and rebuilding reports and processes during our system migration, and over the past several months has collaborated with our background check processor to update and streamline our method for processing background checks. She really took the initiative on this project and it's already proving to be a huge improvement.

Publishable Summary:

This quarter saw the SCA Corporate Office through some exciting changes, despite some remarkable challenges. All in all, we were without an online membership system for the majority of January and the first week of February, during which time we processed nearly \$13k in memberships and subscription renewals manually. As many of you know, the San Francisco Bay Area, and in particular the Santa Cruz Mountains where your intrepid office staff both reside, was affected by unprecedented severe weather and widespread power outages this winter. We spent several weeks in a state of emergency and while every attempt was made to get to as many emails and inquiries as possible during this period, a number of communications and requests were regrettably delayed.

In spite of this, the long-awaited transition to the new CRM system, Neon One, was successfully completed and the updated Member Portal went live on February 8. Since that time, we have been working through various issues to be expected from any major systems change or data migration, as well as a few unexpected ones given our unique needs as an organization. I am happy to report that nearly all issues affecting member profiles have been resolved, and more features are in the works. Please reach out to us at membership@sca.org if you have any questions, concerns, suggestions, or accolades. We thank you again for your continued patience during this transition, and thanks as well to everyone who has already offered valuable feedback, notes, and support.

If you've renewed your membership during the past quarter and elected to receive a paper membership card, keep an eye on your mailbox. While in-office production of paper cards was

temporarily paused during the system changeover, all cards from the past quarter through mid-April have gone out via USPS this past week and will continue to be mailed out regularly – twice a month for the time being.

Nearly 50% of members elected not to receive a paper membership card at all, which brings me to my next exciting news: we will shortly be launching a fully digital option for your SCA membership card, which will integrate with your mobile wallet and show all of your details in one place! These proof of membership details will of course continue to be accessible through the Membership Portal.

In February we began rolling out an updated background check process which streamlines the flow of information between members, Seneschals, and our office. Additionally, all members applying for a background check are now able to input their own information via a secure link-based system, which will reduce duplication of efforts and reduce the number of touches on personally-identifiable data as it moves through the system.

I'm also happy to say we're in the process of updating and digitizing the insurance certificate ordering process. You now have the option to pay any associated fees using a direct credit card link, and a new online form is coming.
